Subject: The annual deferred interest rate has been increased to 24%.

The annual deferred interest rate, which was applied as 15%, has been increased to 24% as of July 21, 2022.

Such change of rate has been executed through General Communiqué on Collection (Serial:C Serial No:6) Published on Official Gazette dated July 21,2022.

Accordingly, a deferred interest of 24% per annum will be applied to the public receivables deferred based on the applications to be made as of July 21, 2022 pursuant to Article 48 of the Law No. 6183.

The former postponement interest rate (15%) will be applied to the public receivables that will be deferred based on the applications made before 21 July 2022 and to the public receivables that were postponed before 21 July 2022 and are paid in accordance with the postponement requirements as long as they are paid in accordance with the postponement requirements.
