Subject: The claim period for refund receivables arising from transactions subject to reduced rates for the calendar year 2021 expires on 31.12.2022.

The deadline for claiming VAT refunds arising from transactions subject to reduced rates in the 2021 calendar year is Monday, December 26, 2022, which is the last day of submission of the 2022/November VAT declaration. Refund request should be made with the VAT return of 2022/November period at the latest.

Taxpayers, which would not make any request of refund until the above date (or through submitting correction declaration until 31.12.2022) shall lose their right.
