**Subject: The 0% withholding tax applied to income from government bonds, Treasury bills and lease certificates which are issued by HM VKŞ has been extended until 30 April 2023.**

In accordance with the Presidency Decree numbered 4937 (OG: 22.12.2021), the rate of withholding on income and gains from government bonds and Treasury bills acquired between 22 December 2021 and 31 December 2022 (including this date) and lease certificates issued by Treasury asset leasing companies was determined as 0% (zero).

According to Presidency Decree numbered 8002 published on Official Gazette dated December 28, 2023, implementation period of such rate reductions has been **extended until April 30, 2024.**
