Subject: The monetary limits to be applied in 2024 have been announced for the disabled to be able to purchase passenger cars as exempt from SCT.

Pursuant to Article 7 of the Special Consumption Tax (SCT) Law; disabled people can purchase vehicles (passenger car, panelvan, pick-up, land vehicle, ATV, jeep, station wagon etc.) in tariff position 87.03 without SCT on their first acquisition for which the total price of which does not exceed 1,004,200 TRY for 2023, including SCT and all other taxes in the framework of requirements mentioned in the related article.

With the Serial No 12 SCT General Communiqué published in the 2nd repeated Official Gazette dated 30 December 2023, the above monetary limit has been determined as 1.591.200 TRY for the year 2024.
