**Subject: Submission and payment terms of 2024- 1st period advance tax declarations have been extended until May 22, 2024.**

Periods of income and corporate advance tax returns, which should have been submitted until May 17, 2024, of 1st period of 2024 (January-February-March) and payments terms of taxes accrued based on such returns **have been extended to the end of May 22, 2024, Wednesday** according to Tax Procedure Law Circular no.168 published by Turkish Revenue Administration on May 15, 2024.
