## Türkiye

Türkiye rescinds visa exemption for nationals of Tajikistan

### Executive summary

On 6 April 2024, the Turkish government announced that nationals of Tajikistan must obtain a visa prior to entering Türkiye for business, tourism or personal purposes.

### Key developments

Tajikistan nationals who seek to enter Türkiye from this date onward must apply for, and obtain, an entry visa from a Turkish consulate prior to travel. Applicants may consult the relevant consulate to confirm specific application document requirements and processing times.

### Impact on employers

Employers that deploy business travelers from Tajikistan to Türkiye may plan accordingly to mitigate business disruptions.
